

IV. Description of Findings and Conclusions

The management agreement between ARHC APNVLMI01 TRS, LLC and Cedarhurst of Northville Management, LLC reads that the management company shall make reasonable efforts to obtain and maintain all licenses and permits required of the licensee. The management company shall also take all action requested by licensee in order for the licensee to maintain and comply with requirements related to the facility's home for the aged license.

V. Recommendation


