II. Purpose of Addendum

On January 20, 2021, Paul Wyman, Licensee Designee submitted a *Request for Modification of the Terms of the Registration/License* requesting a change in age requirement from 60 years old to 50 years old. The second modification is to add physically handicapped to the license programs.

III. Methodology

01/20/2021- Telephone call received from Sera Henry, Administrator inquiring on how to reduce the age of the facility and add a program.

01/20/2021- Document Sent, emailed Modification Request for to Sera Henry- Administrator and Paul Wyman, Licensee Designee.

01/20/2021- Document Received, email Modification Request received from Paul Wyman, Licensee Designee.

01/26/2021- Document Received, updated admission policy and program statement reflecting change in age and adding physically handicapped.

IV. Description of Findings and Conclusions

The facility is currently requesting to lower the admission age of aged residents to 50 years and to add add physically handicapped as a program type of the license. The Original LSR documents that the facility is barrier free and wheelchair accessible thus appropriate for residents with physical handicaps. The Licensee Designee and Administrator both have more than one year of experience working with residents who have physical handicaps. Further the facility currently has physically handicapped residents who were admitted under the program of aged. On 01/26/2021, I received and reviewed the updated admission policy and program statement which meet the criteria outlined in the Public Act 218.

V. Recommendation

I recommend approval for the age requirement to be decreased to 50 years old being the minimum age for admission. I also recommend approval for physically handicapped to be added as an approved program for the license.
