**II. Purpose of Addendum**

The facility has requested for a former resident sitting area into a new private resident room which would increase their bed capacity to 39.

**III. Methodology**


On 1/25/21, Bureau of Fire Services issued a satisfactory fire safety rating.  
On 2/9/21 Health Facilities Engineering Section approved the occupancy to be increased to 39 beds.  
On 2/16/21, licensing staff received new floor plans for the facility.

**IV. Description of Findings and Conclusions**

On 2/17/21, I conducted a video inspection at the facility. I observed Room 406. The new room had a closet, small kitchenette area, and an attached bathroom. The bedroom square footage was consistent with the square footage of other one-bedroom units at the facility. The facility has adequate day dining space to support an additional licensed bed. I found no issues with the addition of the room.

**V. Recommendation**

I recommend the license capacity to be increased to 39.


