II. Purpose of Addendum

The purpose of this addendum is to increase the facility's capacity from four (4) to six (6) residents.

On 06/25/2020, I received a request for medication of the terms of the license.

On 10/29/2020, I conducted an onsite inspection.

IV. Description of Findings and Conclusions

Resident bedrooms were measured during the on-site inspection and have the following dimensions:

Total capacity: 6

The living, dining, and sitting room areas measure a total of 454.88 square feet of living space. This exceeds the minimum of 35 square feet per occupant requirement. Based on the above information, it is concluded that this facility can accommodate six (6) residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend the facility's capacity is increased from four (4) to six (6) residents.
