The licensee has amended this policy to state that staff need only remain awake at night if a resident's Individual-Plan-Of-Service states this is necessary.

IV. Description of Findings and Conclusions

On 11/24/21, the licensee emailed me and asked that an amendment be made to his Original Licensing Study Report. He said that he has changed his awake staff policy to reflect that nighttime staff only need to be awake if the facility has a resident that requires awake staff. This documentation will be reflected in the resident's Individual-Plan-Of-Service.

V. Recommendation

I recommend that the Original Licensing Study Report be amended to reflect that nighttime staff will only be required to remain awake if a resident's IPOS states it is necessary.
