IV. Description of Findings and Conclusions

Resident bedrooms, were measured and have the following dimensions:

Total capacity: 6

The combined living/dining room measured 24'8" x 6', the recreation room measured 20' x 10' which totals of 347.67 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate **six (6)** residents. It is the licensee's responsibility not to exceed the facility's licensed capacity of **six (6)** residents.

I recommend no change to the status of this license


