On 07/29/2021, I obtained the resident bedroom and resident living space measurements.

IV. Description of Findings and Conclusions

Resident bedrooms and living spaces were measured and have the following dimensions:

Total capacity: 6

The living, dining, and sitting room areas measure a total of 962.82 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate **six (6)** residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend no change in the status of this license.


