The purpose of this addendum is to add the length and width dimensions of the resident bedrooms and living spaces.

IV. Description of Findings and Conclusions

Resident bedrooms were measured during the on-site inspection and have the following dimensions:

Total capacity: 6

The living, dining, and sitting room areas measure a total of 710 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate **six (6)** residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend no change in the status of the license.


