IV. Description of Findings and Conclusions

On 07/29/2021, I obtained updated measurements and the bedrooms have the following dimensions:

2	10'4" x 9'10"	101.61	1
3	11'8" x 11'0"	128.33	1
4	9'0" x 10'5"	93.75	1
5	12'0" x 9'11"	119	1
6	16'0" x 9'11"	167.76	1

Total capacity: 6

The living room measured 30'8" x 12'0". The family room measured 21'6" x 13'10" which equals 626 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate **six (6)** residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend no change to the status of the license.
