ALLEGATION: The licensee mistreats residents.

**INVESTIGATION:** Since the resident's guardians requested anonymity, I will not use or list their names in this report.

I interviewed licensee Jody Josephson at the facility. Ms. Josephson denied mistreating any residents. She stated she feels the complaint was made by a former direct care staff she recently let go.

I interviewed all six residents at the facility (Resident A, B, C, D, E and F). Although all six of them have some form of Alzheimer's and/or dementia, they each stated they were satisfied and treated well.

I interviewed the five guardians who have a resident at this home. Resident F does not have a guardian. All five guardians stated they are satisfied with the treatment and care their family members or wards are receiving.

I conducted an exit conference with Jody Josephson. She agreed with the findings.

APPLICABLE RULE	
R 400.1412	Resident behavior management; prohibitions.
	(1) A licensee shall not mistreat or permit the mistreatment of a resident by responsible persons or other occupants of the home. Mistreatment includes any intentional action or omission which exposes a resident to a serious risk or physical or emotional harm.
ANALYSIS:	No evidence was discovered through this investigation which would support the allegation.
CONCLUSION:	VIOLATION NOT ESTABLISHED
