## II. Purpose of Addendum

Addition built onto the home, consisting of three bedrooms and increase the capacity to 6 residents.

#### III. Methodology

On February 17, 2021, the licensee requested a modification of the original license for the addition of three bedrooms and to increase the capacity of the facility from 3 to 6 residents. An onsite inspection of the facility was completed on April 8, 2021.

# IV. Description of Findings and Conclusions

The facility was originally licensed for 3 residents. The addition is located on the east end of the facility. The addition consists of the Licensee's bedroom, two resident bedrooms, a living room, dining room, and a full bathroom. Each resident bedroom has at least one window and a closet. The bathroom has a sink, toilet, and a shower. In the addition, the Licensee's bedroom is 16'x30', Resident Bedroom #1 is 11'x12', and Resident Bedroom #2 is 11'x11'7". Resident Bedroom #1 is 132 square feet and can consist of 2 residents. Resident Bedroom #2 is 129 square feet and can consist of 1 resident. The living room in the addition has the dimensions 26'6"x12' and the dining room in the addition has the dimensions 11'9"x12'. Each room has an exit door and window. The addition has an emergency exit that is wheelchair accessible.

## V. Recommendation

I recommend the original license be amended and the facility capacity be increased to 6 residents.
