The purpose of this addendum is to increase the home's capacity from 4 to 5 adult foster care residents.

IV. Description of Findings and Conclusions

This adult foster care home is located on the outskirts of Gaylord, Michigan. The home has three bedrooms for resident use. Bedrooms #1 and #2 are located upstairs. Bedroom #3 is located on the main floor level beyond the laundry room. The bedrooms have the following dimensions and capacity:

Room	Dimensions	Usable Floor Space	Capacity
Bedroom #1	13'3" x 11	146 square feet	2 residents
Bedroom #2	12 x 11	132 square feet	2 residents
Bedroom #3	10 x 9'6"	95 square feet	1 resident

The required living space is at least 35 square feet per resident. The living room is 15 feet 6 inches by 15 feet. The dining room is 11 feet 6 inches by 9 feet. These two rooms provide 336 square feet of living space which exceeds the requirement. The kitchen and another main level living room is also available as living space for the residents.

There is a resident bathroom upstairs and one downstairs, each available for resident use. The exit from the upstairs of the home is the stairs leading to the main level. There are several exits from the downstairs of the home. The two exits designated as emergency exits include the front door and the door leading through the garage. Fire drills are practiced through the front door of the home with the residents meeting in the front yard away from the home.

V. Recommendation

I recommend that the capacity of this special certification family home be increased from 4 to 5 residents.
