The Mitten Adult Foster Care LLC will focus on care to individuals are aged, physically handicapped, mentally ill, and/or developmentally disabled. The Mitten Adult Foster Care LLC will help residents maintain their highest possible level of functioning, keep them active, alert, independent and content. This will be accomplished through a structured environment, assessment plans with realistic goals and well-trained compassionate staff who will closely monitor and supervise all residents.

#### V. Recommendation

I recommend that Mentally III and Developmentally Disabled program types are added to the license for The Mitten Adult Foster Care LLC. It is the licensee's responsibility not to exceed the facility's licensed capacity of (12) twelve at any time.
