On October 4, 2021, licensee designee Mary Bishop submitted a modification request to add physically handicapped as a program type to the license for Cottage Grove Estates.

III. Methodology

On October 11, 2021, licensee designee Mary Bishop submitted documentation qualifying her to provide care to those that are physically handicapped.

IV. Description of Findings and Conclusions

Based on a review of her qualifications and documentation submitted, Ms. Bishop meets the qualifications to provide care to individuals who are physically handicapped.

Cottage Grove Estates, LLC will focus on care to individuals are aged and physically handicapped. Cottage Grove Estates, LLC will help residents maintain their highest possible level of functioning, keep them active, alert, independent and content. This will be accomplished through a structured environment, assessment plans with realistic goals and well-trained compassionate staff who will closely monitor and supervise all residents. When residents require a greater level of care or supervision, then the staffing ratio will be modified to ensure safety. Cottage Grove Estates, LLC will assess for compatibility for all the residents that they provide care for and licensee designee, Mary Bishop will recommend another setting if the facility is not equipped to meet the needs of a resident or as their symptoms and needs change.

V. Recommendation

I recommend that Physically Handicapped program type is added to the license for Cottage Grove Estates. It is the licensee's responsibility not to exceed the facility's licensed capacity of six residents at any time.
