If you contest the issuance of a provisional license and special certification, you must notify this office in writing and an administrative hearing will be scheduled. Even if you contest the issuance of a provisional license, you must still submit an acceptable corrective action plan within 15 days.

## **III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license and special certification.
