### II. Purpose of Addendum

To re-evaluate the licensed capacity.

#### III. Methodology

On 5/19/21, Mr. Kenneth Jordan submitted a modification request to have the license capacity increased from 4 to 5 residents.

On 6/2/21, this Consultant completed an onsite inspection to measure the bedrooms.

On 6/4/21, the licensee provided written proof the room furnishings meet all the rule requirements.

## IV. Description of Findings and Conclusions

Bedroom #1 is being changed from a single-bed room to a double-bed room. On 6/2/21, Bedroom #1 was measured as having 159 square feet of usable floor space. The room measurements are: 10-10 X 14-8.

Therefore, the room size meets the requirement for double occupancy.

## V. Recommendation

Based on the bedroom dimensions and the licensee's request to increase capacity, I recommend the license be modified to accept 5 residents in care.
