II. Purpose of Addendum

Licensee ARHC APNVLM101 TRS, LLC is changing management companies from Cedarhurst of Northville Management, LLC to SLH HTI East Manager, LLC, effective 3/1/2022. The licensee is also requesting the facility name be changed from Addington Place to Addington Place of Northville.

III. Methodology

2/14/22 - Received email from vice president of clinical operations Susan Rice notifying the department that the facility is switching management companies on 3/1/22. Ms. Rice stated that the ownership at the community will remain the same. At the same time, Ms. Rice submitted their proposed management agreement with SLH HTI East Manager, LLC and a revised BCAL 1600 application listing the new management company.

3/9/22- Email received from Ms. Rice asking to change facility name.

3/10/22- Email received form authorized representative Stephen Levy containing a signed operational narrative outlining the facility name change.

IV. Description of Findings and Conclusions

The management company will be changed to SLH HTI East Manager, LLC to begin on 3/1/2022. The facility name change is effective 3/10/2022.

V. Recommendation

I recommend the proposed changes in the licensee management company and facility name change. The status of the license will remain unchanged.
