### **ALLEGATION:**

On 2/10/2022, there was a queen-sized air mattress with bedding on it in the living room that night staff was taking care of and her two small boys. Concern of 1 1/2-year-old and 4-year-old spending the night at the facility.

# **INVESTIGATION:**

On February 11, 2022, I interviewed Licensee Designee, Judy Schiavone regarding the allegation. Mrs. Schiavone reported Staff, Jessica Truckner has brought her children with her to work due to not having appropriate child care. Ms. Truckner is having family issues and sometimes her babysitter is not be available resulting in Ms. Truckner taking the children to the facility so she can work.

On April 4, 2022, I completed an unannounced on-site inspection at Schiavone AFC V and interviewed Staff, Alexis Perez, Resident A, Resident B, and Licensee Designee, Judy Schiavone. The allegations were discussed with Ms. Perez who reported Staff, Jessica Truckner has brought her children to the facility if she does not have child care. Ms. Truckner works 3<sup>rd</sup> shift and there is one staff member on duty during the 3<sup>rd</sup> shift. According to Ms. Perez, the children are well behaved and do not upset or bother the residents.

On April 4, 2022, I interviewed Licensee Designee, Judy Schiavone who reported there are currently 4 residents who reside at the home. There is 1 staff person who works during the midnight shift (10pm-6am). Staff, Jessica Truckner works the midnight shift and has brought her children to the home when she does not have child care available. When the children stayed the night, they slept on a blow-up bed in the living room. Mrs. Schiavone advised she has spoken to Ms. Truckner about her finding appropriate child care during the time she is at work. According to Mrs. Schiavone, the residents sleep until 8am and Ms. Truckner can care for the residents when the children are at the facility. Resident A and Resident C utilize walkers, Resident B is mobile, and Resident D uses a wheelchair. Resident D is a one-person assist to get into the wheelchair and then can maneuver the chair on her own.

On April 4, 2022, I interviewed Resident A who reported she has lived at her home for a couple years and likes it. Resident A reported that she receives good care at her home. Resident A confirmed that she is familiar with Staff, Jessica Truckner and her children have stayed the night at the facility before. The children will sleep on a mattress on the living room floor. Resident A reported Ms. Truckner is available to assist her when needed when the children are at the home. Resident A denied any current concerns.

On April 4, 2022, I interviewed Resident B who reported she has lived at her home for 5 years and likes her home. Resident B reported Staff, Jessica Truckner has 2 children who are about 5 and 1 years old. The children have spent the night at the facility and slept on a mattress on the living room floor. Resident B reported the children are "no trouble" and she loves children. Ms. Truckner can assist Resident B with whatever she needs when the children are at the home. Resident B reported staff treat her well and denied any current concerns.

On April 5, 2022, I interviewed Staff, Jessica Truckner regarding the allegations. Ms. Truckner reported she has brought her children who are 1 and 4 years old to work with her at Schiavone AFC V due to not having child care. Ms. Truckner reported the children going to the facility with her is not a frequent occurrence and Licensee Designee, Judy Schiavone has since talked to her about this. Ms. Truckner reported if she is unable to find appropriate child care, she tries to find a coworker to work for her and she does not go into work.

APPLICABLE RULE		
R 400.14408	Bedrooms generally.	
	(2) A living room, dining room, hallway, or other room that is not ordinarily used for sleeping or a room that contains a required means of egress shall not be used for sleeping purposes by anyone.	
ANALYSIS:	It was alleged that the living room was being utilized for sleeping purposes by staff children. Upon completing investigative interviews with residents and staff there is a preponderance of evidence to conclude a rule violation.	
	Staff, Alexis Perez, Licensee Designee, Judy Schiavone, Resident A and Resident B confirm Staff, Jessica Truckner has brought her children to work with her during the midnight shift. The children slept in the living room on a blow-up mattress when at the facility.	
CONCLUSION:	VIOLATION ESTABLISHED	

On April 5, 2022, I conducted an Exit Conference with Licensee Designee, Judy Schiavone. I advised Ms. Schiavone I would be requesting a corrective action plan regarding the cited rule violation.

# IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, I recommend no change in the license status
