II. Purpose of Addendum

To increase the capacity of Meadows by the Lake from 16 residents to 20 residents.

III. Methodology

During the original inspection, upon realizing another bathroom with shower would be needed to license with a capacity of 20 residents, Meadows by the Lake was originally licensed with a capacity of 16 residents because there were only two bathing facilities (R 400.15407.4). Resident bedrooms #9 and #16 have not been used as resident bedrooms during the initial six months temporary period of the license but those two resident bedrooms will now be used as double occupancy resident bedrooms.

Ms. Kirtley confirmed this addition was completed on March 3, 2022 and an on-site inspection was completed on March 4, 2022, to see the new shower and the two resident bedrooms that would now be used, each as a double occupancy room. There continues to be ample living space for 20 residents.

On March 17, 2022, Philip Scheer from Bureau of Fire Services confirmed that a new site plan and inspection was not needed because there were no structural changes to the facility.

IV. Description of Findings and Conclusions

The addition of another shower at Meadows by the Lake was completed and allows Licensee designee Ms. Kirtley to be licensed for a capacity of 20 residents.

V. Recommendation

I recommend the capacity for Meadows by the Lake be changed from 16 to 20 residents.
