ALLEGATION: Environmental Health Reported from Mid-Michigan District Health Department reported the well tested positive for Coliform.

INVESTIGATION:

On May 03, 2022, an *Environmental Health Inspection Report* was received from MidMichigan District Health Department documenting Mary's Foster Care Home facility tested positive for coliform bacteria in the water sample and was in substantial non-compliance with environmental health rules. The inspection and testing were completed on April 19, 2022. The *Environmental Health Inspection Report* recommended that the facility has the water system chlorinated and retested.

On May 3, 2022, I contacted licensee Mary Parsons and explained the process and steps that need to be taken to resolve the issue of the coliform bacteria by contacting a well driller, having plumbing and well chlorinated and the well driller retesting the water until the water sample is negative. I advised Ms. Parsons to used bottled water or boiled water to ensure the safety of the water for residents and household members until the water tests negative for coliform bacteria.

On May 19, 2022, I completed an onsite investigation. Licensee Mary Parsons reported the health department retested on May 16, 2022, with the results expected next week. Ms. Parsons completed a corrective action plan and provided the department with the plan.

APPLICABLE RULE		
R 400.1424	Environmental health.	
	(1) The water supply shall be adequate, of a safe and sanitary quality, and from an approved source. Hot and cold running water under pressure shall be provided.	
ANALYSIS:	Mary's Foster Care Home was inspected and a water sample taken on April 19, 2022, by MidMichigan District Health Department. The water sample taken from the facility well tested positive for coliform bacteria leaving the water source to be an unsafe and unsanitary source for resident use and the facility in substantial non-compliance with environmental health rules. The licensee agreed to contact a week driller to chlorinate the well and use bottled or boiled water until a negative test is received.

IV. RECOMMENDATION

An acceptable corrective action plan has been received and approved. It is recommended that the current status of the license remains unchanged.
