### II. Purpose of Addendum

The facility has requested to reduce the licensed bed capacity from 301 to 116.

#### III. Methodology

On 5/16/2022, licensing was notified by the facility administrator Kathleen Butler that de-licensing the second, fourth and fifth floors of the facility was effective 5/20/2022, in which residents were part of the Life Plan community and would reposition to Independent Living. The third floor of the facility would remain a licensed Home for the Aged with 72 beds in which there was a designated space for day/dining/activities as well as a sign-in book for visitors at the floor's front desk. Additionally, the 44 licensed Home for the Aged memory care beds located on the first floor within the Care and Rehabilitation would remain unchanged.

On 6/23/2022, Health Facilities Engineering Section (HFES) staff Andrew Weber conducted an on-site inspection of the facility.

Review of the HFES room sheets for licensed Home for the Aged, The Manor at Glacier Hills, dated 7/7/2022 by surveyor Andrew Weber revealed the square footage of each of the 72 rooms on the third floor was determined to be 185, 230, 291, 307, 309, 411, 501, or 566 square feet, which exceeded the square footage requirements set by the administrative rule for both single and double occupancy rooms. Additionally, the room sheets revealed the square footage of the third-floor day/dining/activity space was 2,686 square feet, which also exceeded the square footage requirements set by the administrative rule.

## IV. Description of Findings and Conclusions

On 7/13/2022, I reviewed HFES room sheets with manager Andrea Moore. I find no conflicts with the identified licensed bed reduction.

## V. Recommendation

It is recommended that The Manor at Glacier Hills de-license 185 beds on the second, fourth and fifth floors of the Manor building in which the third floor and the secured memory care unit of the Care and Rehabilitation Building would remain licensed as a Home for the Aged with 116 beds effective 5/20/2022.
