## II. Purpose of Addendum

On 06/22/2022 licensee Kimberly Hughes submitted a written request for a modification requesting her family home license be amended to reflect that the home added a full bathroom, theater room and a wheelchair ramp.

#### III. Methodology

On 06/09/2021, I conducted a renewal inspection and observed the addition that have been added to the home.

- A full bathroom which contained a shower, a toilet, and a sink.
- The theater room that was added that contained 5 lazy boy chairs and a large television.
- A wheelchair ramp was added to the front of the house to make the home wheelchair accessible.

On 06/22/2021, licensee Kimberly Hughes requested in writing for the terms of her family home license be amended to reflect the home added a full bathroom, theater room and a wheelchair ramp on the front of the house. The family home is also roomy enough to accommodate a resident using a wheelchair throughout the home, bedrooms, and bathrooms.

## **IV.** Description of Findings and Conclusions

On 06/09/2021, I talked with licensee Kimberly Hughes who requested that he license be modified to include wheelchair users since the wheelchair ramp has been added and the home can accommodate a resident who regularly uses a wheelchair. On 06/22/2022, licensee Kimberly Hughes submitted a written request to have the license amended.

## V. Recommendation

I recommend that the license be amended to include wheelchair users.
