### ALLEGATIONS:

It is alleged that Staff- Latroya Banks sits in her car while working.

### **INVESTIGATION:**

On 07/11/2022, I telephoned Licensee Designee/ Administrator – Asari Offiong and Staff- Chidinma Onyenach regarding the above allegations. Ms. Offiong stated she

has no knowledge of any staff waiting in their cars during working hours. Ms. Offiong stated there are cameras installed in the facility as well.

Ms. Onyenach stated she arrived at the facility to begin her shift at 11:30 p.m. and could not locate Staff- Latroya Banks. Ms. Onyenach stated she discovered Ms. Banks sitting in her car, smoking a cigarette. Ms. Onyenach stated she is unsure of the timeframe in which Ms. Banks was sitting her car. Ms. Onyenach stated she did inform Asari Offiong.

On 07/21/2022, I completed an unannounced onsite inspection and interviewed Staff- Demarco Duncan and Residents A- B regarding the above allegations. Mr. Duncan denied the allegations. He stated he only works two days a week during the day time. Mr. Duncan stated the residents attend day program on Mondays, Wednesday, and Fridays. He stated Ms. Banks no longer works at the facility. Mr. Duncan stated there is Ms. Onyenach and himself working at the facility.

Residents A and B stated staff has left them in the facility for no longer than 15 minutes and will sit in their car. Residents A and B where not able to identify the staff nor provide the number of times this has occurred. Both Residents A and B stated the staff do come back into the facility.

ANALYSIS:	Ms. Onyenach stated she arrived at the facility to begin her shift at 11:30 p.m. and could not locate Staff- Latroya Banks. Ms. Onyenach stated she discovered Ms. Banks sitting in her car, smoking a cigarette. Ms. Onyenach stated she is unsure of the timeframe in which Ms. Banks was sitting her car.	
	Residents A and B stated staff has left them in the facility for no longer than 15 minutes and will sit in their car. Both Residents A and B stated the staff do come back into the facility.	
	Therefore, there was not sufficient direct care staff on duty at all times for the supervision and protection of residents.

Contingent upon an acceptable corrective action plan, I recommend the continuation of the provisional license from LSR dated 08/19/2022 and CAP dated 09/04/2022.
