**II. Purpose of Addendum**

Mr. Gabay requested to increase the capacity of the home for the aged (HFA) by adding an additional 17 licensed beds for room numbered 2014 N and 216 N - 224N.

**III. Methodology**


On 7/15/2022, Mr. Gabay applied to increase to licensed beds. On 8/4/2022, I completed an on-site inspection. The Health Facilities Engineering Section room sheets were reviewed for the rooms identified to have an increase in beds.

**IV. Description of Findings and Conclusions**

I reviewed HFES room sheets and determined that rooms numbered 2014 N and 216 N - 224N. Three rooms are one licensed bed with 138 sq ft, built in closets, connected bathrooms. Seven rooms are two licensed beds with 160 sq ft of floor space, built in closets, and connecting bathrooms. The adjacent rooms share connecting toilet rooms. Day/dining space is adequate to support this increase of 17 licensed beds.

**V. Recommendation**

It is recommended that the license capacity increase to reflect 108 licensed beds.
