II. Purpose of Addendum

Licensee Designee, Priscilla Espinosa, would like to update the terms of her license to include serving individuals with developmental disabilities in her program statement. She would also like to expand the age range of her residents from 50-99 to 18-99 years of age.

III. Methodology


Ms. Espinosa has submitted a *Request for Modification of the Terms of the Registration/License* form requesting that the program type be updated to include individuals with developmental disabilities and that the age range be modified from 50-99 to 18-99 years of age. Ms. Espinosa provided documentation of an updated resume, which highlighted 10 years of experience working with this population. She also provided an updated Program Statement, identifying developmentally disabled and elderly residents to be served by the facility direct care staff.

IV. Description of Findings and Conclusions

Ms. Espinosa's resume identifies at least ten years of experience working with the developmentally disabled population through medical care jobs where she has maintained employment. She has worked with varying age levels and understands the importance of assessing new residents to ensure they will be a good fit with current residents in the facility.

V. Recommendation

I recommend that the program type of the facility be updated to include individuals with developmental disabilities and that the age range be modified to 18 – 99 years of age. Ms. Espinosa has provided documentation noting her experience in working with this population.
