To re-evaluate licensed capacity.

#### III. Methodology

Onsite inspection on 09/15/2022 to re-measure Bedroom #3.

## IV. Description of Findings and Conclusions

On 09/09/2022, the licensee designee submitted a written request to increase capacity to 4 residents. At the time of licensure, Bedroom #3 was approved for 1 resident. The doorway in Bedroom #3 was not included in the initial measurement, therefore, the licensee designee requested that it be measured.

The home was originally licensed for 3 residents with the following dimensions:

Bedroom #1-114 sq ft (1 resident) Bedroom #2-102 sq ft (1 resident) Bedroom #3-124 sq ft (1 resident)

On 09/15/2022, I conducted an onsite inspection at the facility and re-measured Bedroom #3, including the doorway. It had the following dimensions and capacity:

Bedroom #3-10 X 12.5 + 3.2 X 2=130 sq ft (2 residents)

Based on the bedroom dimensions and the licensee's request to increase capacity, I conclude that the home can accommodate 4 residents.

## V. Recommendation

I recommend increasing capacity from 3 to 4 residents.
