# ALLEGATION: The facility is not staffed during the early morning hours.

**INVESTIGATION:** On 12/06/2022, I conducted an unannounced on-site investigation at the facility and interviewed staff member Thressa Steffes and Residents A, B and C regarding the above allegation.

Resident A stated that his routine in the morning is being woken up by overnight staff person Jenn Diamond around 6:15 a.m. He then gets ready for school, comes downstairs, takes his medications, and catches a bus at 6:50 a.m. Resident A stated there was an occasion within the past week when Ms. Diamond administered his medications then around 6:40 a.m. she left the facility with no other staff member on duty. She explained to him that she had to get to her other job. Resident A stated he left 10 minutes later when his bus had arrived. He stated, "I don't know who came in or when after that because I left."

Residents B and C stated that as far as they are aware the facility is always staffed. Both acknowledged they do not get up until after 7:00 a.m.

Staff member Thressa Steffes reported there was at least one occasion when she arrived at work the previous week at 7:00 a.m. and staff member Jenn Diamond had left for work early thus leaving residents unattended. She stated her shift begins at 7:00 a.m..

On 12/19/2022, I spoke with staff member Jenn Diamond who acknowledged that she left the facility early on one occasion within the past few weeks. She stated she left before any other staff were on duty. She stated since then, Licensee Suzanne Lange has told her this must never occur again. She stated she will not do this again.

On 12/19/2022, I conducted an exit conference with Licensee Suzanne Lange and reviewed the findings of the investigation. She agreed that this is a serious violation. She has spoken to Ms. Diamond about never leaving the facility while residents are in the home. She has offered to pay other staff members to come in early if Ms. Diamond feels she needs to leave. Ms. Lange will provide a plan of correction.

APPLICABLE RULE	
R 400.14206	Staffing requirements.
	(1) The ratio of direct care staff to residents shall be adequate as determined by the department, to carry out the responsibilities defined in the act and in these rules and shall not be less than 1 direct care staff to 12 residents and children who are under the age of 12 years.
ANALYSIS:	According to statements made by Resident A and staff members Ms. Steffes and Ms. Diamond, there was at least one occasion when the ratio of direct care staff to residents was not adequate. Residents were left unattended with no staff on duty.
CONCLUSION:	VIOLATION ESTABLISHED

# IV. RECOMMENDATION

Upon receipt of an acceptable plan of correction I recommend the status of this license remain unchanged.
