## **II. Purpose of Addendum**

The local Bureau of Family Services (now known as Office of Children and Adult Licensing) in Flint received a request for an increase in capacity from a four resident to a six resident facility.

## **III. Methodology**

- 11/24/2004 Local Bureau of Family Services receives written request.
- 1/12/2004 Case file transferred to this consultant.
- 1/21/2004 This consultant conducts inspection of facility and interviews Anna Paige, the administrator.
- 1/22/2004 This consultant completes an Addendum to the original Licensing Study Report.

## **IV. Description of Findings and Conclusions**

The Kimberly Oaks Home opened in September of 1990 with 4 developmentally-developed residents. At the time the proposed facility was an AIS/MR home for 6 adults. The placing agency was and remains Genesee County Community Mental Health Authority.

On 11/21/2004 this consultant measured two bedrooms:

- >Southwest bedroom measured 168 square feet (2 residents)
- >Northeast bedroom measured 163 square feet (2 residents)
- >Northwest bedroom measured 167 square feet (2 residents)

Ms. Paige, the administrator indicated that the 2 new residents would be ambulatory and that staffing would be adequate to serve all six residents. This consultant requested Ms. Paige to update any and all paperwork to reflect the new capacity (6) of the facility.

## **V. Recommendation**

It is recommended that this facility's capacity be increased from 4 residents to 6 residents.
