III. METHODOLOGY

ALLEGATION: Direct care staff member Brittany Labadie fell asleep in the home leaving residents unsupervised.

INVESTIGATION:

On 10/20/2022, I received a complaint through the Bureau of Community Health Systems (BCHS) online complaint system alleging direct care staff member Brittany Labadie was sleeping on the couch leaving residents unsupervised in the home.

On 10/21/2022, I interviewed Complainant who reported direct care worker Brittany Labadie was observed sleeping on the couch during work hours leaving residents unsupervised in the home. Complainant stated this is an ongoing issue with direct care staff member Brittany Labadie and the resident who observed her sleeping took a picture. Complainant also alleged the facility is a mess.

On 10/24/2022, I conducted an unannounced onsite investigation and interviewed home manager, Heather Cortes who reported Brittany Labadie is employed as a direct care worker (DCW), began her employment with Beacon Specialized Living Services in February 2022. Ms. Cortes denied that she has ever physically observed DCW Labadie sleeping during her work shifts, but she recently became aware on 10/19/2022 DCW Labadie sleeping on the couch during her dayshift while she was supposed to be supervising two to three residents. Ms. Cortes stated she was aware DCW Granado and Resident A observed DCW Labadie sleeping on the couch and that Resident A had taken a picture of DCW Labadie sleeping. Ms. Cortes reported addressing this behavior with DCW Labadie informing her this was unacceptable and cannot continue to happen.

On 10/24/2022, I interviewed direct care workers (DCW) Whitney Powell and DCW Gillian Johnston who both denied ever witnessing DCW Brittany Labadie sleeping or leaving residents unsupervised during her daytime work shifts at the home.

On 10/24/2022, I interviewed direct care worker (DCW) Maria Granado who reported working daytime shift with DCW Brittany Labadie on 10/19/2022 where she observed DCW Labadie sleeping twice during their work shift. DCW Granado reported transporting several residents for a daytime outing and leaving DCW Labadie at the home with two or three other residents to supervise. DCW Granado reported prior to leaving the home with the residents she observed DCW Labadie lying on the couch starting to fall asleep. DCW Granado reported she had to wake up DCW Labadie to let her know she was transporting several residents for a daytime outing. DCW Granado reported after returning she walked into the home and observed DCW Labadie sleeping again on the couch. DCW Granado reported after waking up DCW Labadie, she did get up, but she still had concerns because Resident A told her DCW Labadie slept the entire time she was out of the home with the other residents. DCW Granado reported Resident A informed her how she took a picture of DCW Labadie sleeping on the couch. DCW Granado reported addressing her concerns with management. DCW Granado denied ever witnessing DCW Labadie sleeping during any other shifts she has worked with DCW Labadie.

On 10/24/2022, I interviewed Resident A who reported observing DCW Brittany Labadie sleeping on the couch in the home on 10/19/2022 and taking a picture of what occurred. Resident A denied ever witnessing DCW Labadie or any other direct care staff members sleeping in the home prior to this incident.

During my unannounced onsite investigation, I observed a picture of direct care staff member Brittany Labadie sleeping on the couch inside the AFC home.

On 10/27/2022, I interviewed direct care worker (DCW) Brittany Labadie who reported on 10/19/2022 she worked first shift at the home. DCW Labadie reported working the same shift with DCW Granado. DCW Labadie reported DCW Granado transported several residents during the day shift for a day outing and left DCW Labadie at the home to supervise the remaining residents at the home. DCW Labadie admitted lying on the couch next to a resident and falling sleep on the couch. DCW Labadie reported waking up after DCW Granado returned from the day outing with the other residents. DCW Labadie reported this was the first time this has happened during her employment with Beacon Specialized Living Services.

DCW Labadie denied having any knowledge of a picture taken of her sleeping on the couch on 10/19/2022.

On 10/27/2022, I interviewed direct care worker (DCW) Jamie Anderson who reported being employed with Beacon Specialized Living Services since August 22, 2022. DCW Anderson denied ever witnessing DCW Labadie falling asleep during her shift but indicated observing DCW Labadie *attempting* to sleep on the couch during their shared daytime shift. DCW Anderson reported she confronted DCW Labadie and told it was unacceptable sleeping during work hours. DCW Anderson reported DCW Labadie rolled up the blanket, put the blanket in the closet and got onto her computer. DCW Anderson denied ever witnessing any other incidents.

On 11/08/2022, I reviewed *Beacon Specialized Living Services Inc Direct Support Professional Position Description*, which stipulates under the category Responsibilities/Essential Functions, a requirement for every direct care staff member is to remain awake during their work shifts and be accessible in providing care for every resident.

ANALYSIS:	Based on interviews with home manager Cortes, DCWs Powell, Johnston, Granado, Labadie, Resident A, observing a picture taken of DCW Labadie sleeping and reviewing <i>Direct Support</i> <i>Professional Position Description,</i> there is evidence that on 10/19/2022 direct care staff member Brittany Labadie fell asleep on the couch during the time she was the only responsible staff member supervising residents in the home leaving insufficient staff on duty to meet the needs of the residents.	
CONCLUSION:	VIOLATION ESTABLISHED	

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, no change in license is recommended.
