III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

R 325.1922	Admission and retention of residents.
	(7) An individual admitted to residence in the home shall have evidence of tuberculosis screening on record in the home which consists of an intradermal skin test, chest x-ray, or other methods recommended by the local health authority performed within 12 months before admission.
ANALYSIS:	On-site inspection revealed one of the eight resident files reviewed did not have evidence of a tuberculosis screening on record performed within 12 months before admission. Resident A's admission date was 7/15/2016 and the last record of a tuberculosis screening was completed 5/5/2018.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1954	Meal and food records.
	The home shall maintain a record of the meal census, to include residents, personnel, and visitors, and a record of the kind and amount of food used for the preceding 3-month period.
ANALYSIS:	Upon inspection and review of the kitchen, there was no evidence of a record of meal census maintained for the preceding three-month period.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1975	Laundry and linen requirements.
	(1) A new construction, addition, major building change, or conversion after November 14, 1969 shall provide all of the following: (a) A separate soiled linen storage room.

	(b) A separate clean linen storage room.(c) A separate laundry processing room with handwashing facilities in a home that processes its own linen.
ANALYSIS:	On-site inspection revealed no clearly designated soiled linen area or clean linen storage area. The laundry rooms in the facility were also being utilized as storage areas for personal items, maintenance items, furniture, and housekeeping supplies etc. This poses a risk for cross contamination of laundry and linens. Only laundry and linens can be kept in the laundry area.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1976	Kitchen and dietary.
	(6) Food and drink used in the home shall be clean and wholesome and shall be manufactured, handled, stored, prepared, transported, and served so as to be safe for human consumption.
ANALYSIS:	On-site inspection revealed food items (jam, milk, juice, ice cream, soda, condiments, baking items, chicken, beef product, bagged salad, butter, noodles, cereal etc.) in the kitchen refrigerators and freezers, kitchen dry storage area, and memory care refrigerator and cabinets that were unlabeled. An open date must be placed on all food items once opened. It could not be determined if the food items were safe for human consumption.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1976	Kitchen and dietary.
	(13) Multi-use utensil used in food storage, prep, transport, or serving shall be thoroughly cleaned and sanitized – stored and handled protected from contamination. (Dishwashing temps 180F for a plate to reach 160F. If chemical sanitization is also utilized, hot water has to be at 130F.

ANALYSIS:	On-site inspection revealed incomplete dishwasher sanitization records for November 2022 and December 2022. It could not be determined if the multi-use utensils were handled protected or sanitized to prevent contamination.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1979	General maintenance and storage.	
	(1) The building, equipment, and furniture shall be kept clean and in good repair.	
ANALYSIS:	On-site inspection revealed mechanical closets on the main floor and the second floor were being used a storage closets. Items such as therapy equipment, bed side commodes, a shopping cart, furniture, seasonal items etc. were found in the mechanical closets. Mechanical closets are not intended as storage closets and must be kept free of hazards.	
CONCLUSION:	VIOLATION ESTABLISHED	

R 325.1979	General maintenance and storage.
	(3) Hazardous and toxic materials shall be stored in a safe manner.
ANALYSIS:	On-site inspection revealed industrial chemicals easily accessible to anyone on the main floor and second floor hallway bathrooms. This presents a potential risk of ingestion and harm to residents in the home with impaired cognition and function.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan and an approved BFS fire safety rating, renewal of the license is recommended.
