II. Purpose of Addendum

To change the licensee's name and address.

III. Methodology

On 9/27/2022, review of LARA Corporations Division Website read in 1993 the original licensee was CCG Ironwood Inc, then in 2013 the licensee's name changed to Atrium Ironwood Inc, in which the address remained the same. The LARA Corporations Division website read on 1/3/2022, the licensee's name changed to Atrium Ironwood LLC and address was: 2550 Corporate Exchange Drive, Suite 200, Columbus, OH 43231.

Review of the department's facility file revealed the current licensee was C.C.G Ironwood, Inc at address: 5000 Hakes Dr, Suite 600, Norton Shores, MI 49441 with EIN 38-3093245.

Additionally, review of the department's facility file revealed an addendum to the original licensing study report (LSR) was not completed for the licensee's name change from C.C.G Ironwood to Atrium Ironwood, Inc.

On 9/29/22, an on-site renewal inspection was conducted in which AR/Administrator Heather Watt revealed the licensee's name and address was changed in January 2022 which was consistent with LARA Corporations Division Website.

On 10/4/2022, an email correspondence with Ms. Watt provided a letter from the Internal Revenue Service (IRS) confirming the licensee's name change and reassignment of the Employer Identification Number (EIN) number from Atrium Ironwood Inc to Atrium Ironwood LLC. The EIN number read consistent with the department's facility file.

IV. Description of Findings and Conclusions

Review of LARA Corporations Division Website read consistent with the changes provided by Ms. Watt.

Review of a letter dated 1/12/2022 provided by the facility from the IRS read consistent with licensee name and reassignment of the facility's Employer Identification Number (EIN).

V. Recommendation

I recommend the status of this licensee name and address be changed.
