II. Purpose of Addendum

Licensee designee Shahid Imran submitted a written request for a modification to increase the capacity of the license from 13 to 18 due to an increase in the certificate of occupancy.

III. Methodology

On 01/04/2022, I conducted a review of the of the facility file which documented in the Original Licensing Study Report that the facility has 18 bedrooms and the indoor living and dining areas measures over 7,000 square feet of living space. This exceeds the minimum of 35 square feet per occupant requirement.

Emails were exchanged about questions regarding the certificate of occupancy on 06/16/2022, 11/10/2022, 12/07/2022 and 01/04/2023 with licensee Shahid Imran who had already completed a modification form and requested that the capacity of the license be increased from 13 to 18 due to a change in the certificate of occupancy.

IV. Description of Findings and Conclusions

On 1/04/2023, I talked with licensee designee Shahid Imran who requested that the license be modified to increase capacity of the license from 13 to 18. According to the Original Licensing Report, the facility has 18 bedrooms and the indoor living and dining areas measures over 7,000 square feet of living space. Licensee designee Shahid Imran agreed that he would not exceed the licensed capacity of 18 residents at any time. Shahid Imran submitted a written request for this increase in capacity.

V. Recommendation

I recommend that the capacity of the license be increased from 13 to 18 due to a change in the certificate of occupancy.
