II. Purpose of Addendum

To access and determine if Sasse Adult Foster Care Home can accommodate an increase in capacity, from 5 to 6 residents.

III. Methodology

12/22/2022 Contact – Document received; email from Susan Simwenyi, Licensee Designee, requesting increase capacity from 5 to 6.

02/14/2023 Onsite Inspection Completed – assessed and measured bedroom #1 for increased capacity.

IV. Description of Findings and Conclusions

On 02/14/2023 I completed an on-site inspection. I observed that bedroom #1 was clean. Measurements were taken and it has a total of 169 square feet and can accommodate two residents. The facility has 2 full bathrooms and 429 square feet of living space. The facility has enough square footage to support the request of increased capacity from 5 to 6.

V. Recommendation

I recommend that Sasse Adult Foster Care Home adult foster care family home licensed capacity be increased from 5 to 6.
