Direct care workers (DCWs) are working without having physical examinations or tuberculosis tests completed.	Yes
Direct care workers (DCWs) are working without having proper training.	Yes

III. METHODOLOGY

01/04/2023	Special Investigation Intake-2023A0466017.
01/06/2023	Special Investigation Initiated - On Site.
01/19/2023	Contact- Document sent to SarahKate Van Auker.
02/22/2023	Exit conference with licensee designee Rochelle Lyons.

ALLEGATION: Direct care workers (DCWs) are working without having physical examinations or tuberculosis tests.

INVESTIGATION:

On 01/04/2023, anonymous Complainant reported direct care workers (DCW)s are working with residents without having physical examinations and tuberculosis (TB) tests completed. Complainant reported this is putting all staff at risk for contracting diseases. Because Complainant was anonymous no additional information or details could be gathered to clarify the allegation.

On 01/06/2023, I conducted an unannounced investigation and I reviewed seven employee records and found all of the employee records contained physical examinations.

On 01/06/2023, I conducted an unannounced investigation and I reviewed seven employee records and found two employee records (Alisha Lemle and Nicole Holland) that did not contain documentation that a tuberculosis test had been conducted.

On 01/06/2023 I interviewed SarahKate Van Auker, executive director, who reported she would look into Alisha Lemle and Nicole Holland's tuberculosis test results.

On 01/19/2023, I emailed Ms. Van Auker and asked if she had located tuberculosis test results for Arianna Shaw and Nicole Holland. Ms. Van Auker never provided any additional tuberculosis tests as of the date of this report.

	(3) A licensee shall maintain, in the home, and make available for department review, a statement that is signed by a licensed physician or his or her designee attesting to the physician's knowledge of the physical health of direct care staff, other employees, and members of the household. The statement shall be obtained within 30 days of an individual's employment, assumption of duties, or occupancy in the home.	
ANALYSIS:	Complainant reported that direct care workers are working with residents without having physical examination. I reviewed seven employee records and found all the records reviewed contained a statement signed by a physician attesting to the physician's knowledge of the physical health of direct care staff within 30 days of an individual's employment therefore there is not enough evidence to establish a violation.	
CONCLUSION:	VIOLATION NOT ESTABLISHED

(5) A licensee shall obtain written evidence, which sha available for department review, that each direct care so other employees, and members of the household have lested for communicable tuberculosis and that if the discissis present, appropriate precautions shall be taker required by state law. Current testing shall be obtained before an individual's employment, assumption of duties occupancy in the home. The results of subsequent testing shall be verified every 3 years thereafter or more frequent if necessary.		

ANALYSIS:	Complainant reported that direct care workers are working without having tuberculosis tests. I reviewed seven employee records and found two employee record (Alisha Lemle and Nicole Holland) that did not contain documentation of any tuberculosis test results therefore a violation has been established
CONCLUSION:	VIOLATION ESTABLISHED

ALLEGATION: Direct care workers (DCWs) are working without having proper training.

INVESTIGATION:

On 01/04/2023, anonymous Complainant reported direct care workers (DCW)s are working with residents without the hiring process being completed before they are put on the schedule. Because the complainant was anonymous no additional information or details could be gathered to clarify the allegation.

On 01/06/2023, I conducted an unannounced investigation and I reviewed seven employee records. At the time of the investigation, three employee records (Grace Amsterdam, Alisha Lemle and Cherryl Charles) did not contain documentation that these direct care workers had received renewal training on First aid and Cardiopulmonary resuscitation thus showing these workers to be trained in the most current methods and procedures for First Aid and Cardiopulmonary resuscitation. All other required trainings were completed for the seven employee records I reviewed.

On 01/06/2023 I interviewed Ms. Van Auker who reported that she would try to locate documentation that direct care workers Grace Amsterdam, Alisha Lemle and Cherryl Charles had completed current First aid and Cardiopulmonary resuscitation training.

On 01/19/2023, I emailed Ms. Van Auker and asked if she had located current First aid and Cardiopulmonary resuscitation training for Grace Amsterdam, Alisha Lemle and Cherryl Charles. Ms. Van Auker never provided any additional First aid and Cardiopulmonary resuscitation trainings for those three employees.

APPLICABLE RULE	
R 400.15204	Direct care staff; qualifications and training.
(3) A licensee or administrator shall provide in-sert training or make training available through other source direct care staff. Direct care staff shall be competent be performing assigned tasks, which shall include be competent in all of the following areas: (b) First aid. (c) Cardiopulmonary resuscitation.	

ANALYSIS:	Complainant reported direct care workers are working without having proper training. At the time of the investigation, the employee records for Grace Amsterdam, Alisha Lemle and Cherryl Charles did not contain documentation of current completed training in first aid and cardiopulmonary resuscitation therefore a violation has been established.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon the receipt of an acceptable corrective action plan I recommend no change in license status.
