## II. Purpose of Addendum

Ms. Schrotenboer requested existing rooms numbered 202 to 207, 209 to 213, and 215 to 216 to be an extension of the current memory care unit for home the aged (HFA). Rooms numbered 202 to 207, 209 to 213, and 215 to 216 are to become an expansion of the currently existing memory care unit and would operate under the currently existing memory care unit protocols and policies.

# III. Methodology

On 2/17/2023, Ms. Schrotenboer requested rooms numbered 202 to 207, 209 to 213, and 215 to 216 become an extension of the currently existing memory care unit.

On 2/27/2023, I completed an on-site inspection. The Health Facilities Engineering Section room sheets were reviewed for the rooms requested to be an expansion of the current existing memory care unit.

# IV. Description of Findings and Conclusions

I reviewed HFES room sheets and determined that rooms numbered 202 to 207, 209 to 213, and 215 to 216. Fifteen rooms are one licensed bed with 140 sq ft, built in closets, and in-room bathrooms. One room is a two licensed bed with 168 sq ft of floor space, built in closets, and in-room bathroom. Day/dining space remains adequate to support the proposed changed use of this area.

# V. Recommendation

It is recommended rooms numbered 202 to 207, 209 to 213, and 215 to 216 to be utilized as an extension of the current existing memory care unit.
