# **III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

This facility was found to be in non-compliance with the following rules:

R 325.1913	Licenses and permits; general provisions.
	(2) The applicant or the authorized representative shall give written notice to the department within 5 business days of any changes in information as submitted in the application pursuant to which a license, provisional license, or temporary nonrenewable permit has been issued.
ANALYSIS:	It was revealed during the on-site inspection the facility merged with another company and subsequently changed their tax identification number in January 2022. The department was not notified of the changes and therefore, the facility is out of compliance with the licensing department.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1923	Employee's health.	
	(2) A home shall provide initial tuberculosis screening at no cost for its employees. New employees shall be screened within 10 days of hire and before occupational exposure.	
ANALYSIS:	Review of employee records revealed Employee A did not have a TB screening within the 10 days of hire and before occupational exposure. Employee A hire date was 2/13/2017 and the TB screening on file was dated 5/13/2016, which out of compliance with the 10 days of hire and before occupational exposure parameters.	
CONCLUSION:	VIOLATION ESTABLISHED	

R 325.1970	Water supply systems.
	(7) The temperature of hot water at plumbing fixtures used by residents shall be regulated to provide tempered water at a range of 105 to 120 degrees Fahrenheit.
ANALYSIS:	During inspection, it was revealed there was no evidence of testing the hot water temperature of plumbing fixtures used by resident to ensure water temperature was safe and ranged from 105 to 120 degrees Fahrenheit. The water temperature testing records could not be located during the inspection.
CONCLUSION:	VIOLATION ESTABLISHED

R 325.1975	Laundry and linen requirements.	
	<ul> <li>(1) A new construction, addition, major building change, or conversion after November 14, 1969 shall provide all of the following:         <ul> <li>(a) A separate soiled linen storage room.</li> </ul> </li> </ul>	
ANALYSIS:	Soiled linen was discovered in a janitor's closet along with other items (ex. oxygen tanks, vacuum cleaner, therapy equipment, cleaning chemicals etc.). Soiled laundry is to be kept in a separate storage room to prevent cross contamination.	
CONCLUSION:	VIOLATION ESTABLISHED	

R 325.1979	General maintenance and storage.
	(3) Hazardous and toxic materials shall be stored in a safe manner.
ANALYSIS:	During inspection, industrial chemicals and shampoos were discovered in the community bathroom. This poses a risk of harm and ingestion for residents with impaired cognition.
CONCLUSION:	VIOLATION ESTABLISHED

## IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan and paid renewal license fee, renewal of the license is recommended.
