II. Purpose of Addendum

Change the facility name to Sodalis Temperance.

III. Methodology

On 4/19/2023, the Department received email correspondence from authorized representative Catherine Reese to change the facility’s name to Sodalis Temperance. The correspondence provided the following documentation which was reviewed: a BCAL-5055 form completed and signed by Ms. Reese, a letter from Sodalis Senior Living with notification of the management change, a copy of the Certificate of Assumed Name from the LARA Corporations Division website, the date of qualification in Michigan from the LARA Corporation Division website for Trilogy SL Manager, LLC, and the facility's management contract with Sodalis Senior Living.

IV. Description of Findings and Conclusions

On 4/19/2023, I conducted a telephone interview with Ms. Reese who stated Sodalis Senior Living was the facility’s new management company. Ms. Reese stated the ownership, licensee, as well as the licensee’s federal tax number, remained the same. Ms. Reese stated she would remain the appointed authorized representative and there would be no other changes to staff currently working within the facility.

V. Recommendation

I recommend the facility’s name be changed to Sodalis Temperance.
