II. Purpose of Addendum

The purpose of the addendum is to change the facility name from Vibrant Life Senior Living, The Cottage to Sodalis Temperance Assisted Living Cottages.

III. Methodology

On 04/18/23, I received email correspondence from licensee designee, Catherine Reese requesting to change the name of the facility to Sodalis Temperance Memory Care. The following documentation received was a letter from Sodalis Senior Living with notification of the management change, a copy of the certificate of assumed name from the LARA Corporations Divisions website, the date of qualification in Michigan from the LARA Corporations Division website for Trilogy SL Manager, LLC and the facility's management contract with Sodalis Senior Living.

IV. Description of Findings and Conclusions

On 04/27/23, I interviewed licensee designee Catherine Reese. Ms. Reese reported that Sodalis Senior Living is the new management company for all Vibrant Life Senior Living Communities. Ms. Reese confirmed that ownership, licensee, licensee designee and the federal tax identification number will remain the same.

V. Recommendation

I recommend that the facility name be changed from Vibrant Life Senior Living, The Cottage to Sodalis Temperance Assisted Living Cottages.
