II. Purpose of Addendum

The purpose of this addendum is to reflect a change in occupancy for resident room numbers 142 and 131. The facility requested resident room number 142 be changed from a single occupancy room to a double occupancy room and resident room number 131 be changed from a double occupancy room to a single occupancy room.

III. Methodology

On 5/31/23, I received a signed *REQUEST FOR MODIFICATION OF THE TERMS OF THE REGISTRATION/LICENSE* (BCAL 5055) form. A "Change of Use of Space" was requested. The request read, "change room 142 from private to semi-private & change 131 from semi-private to private." This request was signed by the facility's administrator DaleTron Thompson and the facility's authorized representative Lisa Sikes.

On 5/31/23, I reviewed the facility's original licensing study report (OLSR) that is dated 5/20/22. The OLSR outlined resident room 131 as a double occupancy room and resident room 142 as a single occupancy room.

I also reviewed the Health Facility Engineering Section (HFES) room sheets that were updated in 2019. The room sheets identified resident room 142 has enough square footage to accommodate two licensed beds.

IV. Description of Findings and Conclusions

After review of the facility's request to change the occupancy of resident rooms 131 and 142, the HFES room sheets, the facility's OLSR, it was determined there is adequate space to adjust the room occupancies.

V. Recommendation

I recommend resident room number 131 be changed from a double occupancy room to a single occupancy room. I also recommend resident room number 142 be changed from a single occupancy room to a double occupancy room.
