II. Purpose of Addendum

On 11/03/2022, licensee designee Scott Brown submitted a modification requesting the terms of his small adult foster care license be amended to add the program type 'Mental Illness' so the facility can begin to provide care to residents diagnosed with chronic mental illness.

III. Methodology

On 11/03/2022, licensee designee Scott Brown requested the terms of his small adult foster care license be amended to reflect the facility is able and willing to care for residents who have mental illness. On 11/03/2022, I talked with licensee designee Scott Brown who reported that he is currently a licensee designee for another licensed AFC that has served individuals with mental illness since 1999 thus providing him with at least one year of experience working with residents with mental illness as required.

IV. Description of Findings and Conclusions

On 11/03/2022, licensee designee Scott Brown submitted an updated Program Statement that I approved which included mental illness as a program type. I talked with licensee designee Scott Brown who understood and agreed that it is his responsibility to assess residents upon admission and ensure that residents are compatible prior to admission. Additionally, Scott Brown agreed to not exceed the licensed capacity of six residents at any time.

On 11/10/2022, I reviewed the Bureau Information Tracking System and reviewed the facilities for which Scott Brown is the licensee designee. It documented Scott Brown has been the licensee designee for that at least one facility that has been licensed for mental illness since September 2015. He has been approved as having at least one year of experience working with residents diagnosed with mental illness.

V. Recommendation

I recommend that mental illness be added as a program type to the license.
