**II. Purpose of Addendum**

On March 10, 2023, licensee Melinda Lang submitted a modification requesting the terms of her family home be amended to reflect that she is able and willing to care for male residents.

**III. Methodology**

During the onsite renewal inspection on March 7, 2023, Ms. Lang asked if it would be possible to allow males to reside at Home Street Manor if there was an opening. I spoke with Ms. Lang who understood she would need to submit a modification request and she understood only same sex individuals can share a bedroom unless they are a married couple.

On March 10, 2023, licensee Ms. Lang submitted a modification requesting the terms of her family home be amended to reflect that she is able and willing to care for male residents. Ms. Lang is not changing the capacity of six and she has six single occupancy bedrooms in the facility.

**IV. Description of Findings and Conclusions**

Licensee, Ms. Lang understands and agrees that only same sex individuals can share a bedroom unless they are a married couple. Ms. Lang understands that is her responsibility to not exceed the licensed capacity of six residents at any time.

**V. Recommendation**

I recommend that male gender be added to the license.
