III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

R 325.1975	Laundry and linen requirements.
	(1) A new construction, addition, major building change, or conversion after November 14, 1969 shall provide all of the following: (b) A separate clean linen storage room.
ANALYSIS:	On-site inspection revealed items (ex. lost and found items, vacuum cleaners, housekeeping cart and supplies etc.) were stored with clean linens in the clean linen area. This poses a risk for cross contamination of linens. Only clean linens can be kept in the designated clean linen area.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
