ALLEGATION:

Staff Georgia McCaughan threatened Resident A with physical assault.

INVESTIGATION:

APS and ORR referrals were made/received.

On 7/21/2023, I interviewed direct care staffs India Williams and Tyler Dykes. They both stated staff Georgia McCaughan became upset with Resident A, who was having a behavioral incident, and she threatened him with physical assault.

On 7/21/2023, I attempted to interview staff Georgia McCaughan, but she refused to answer any questions related to this investigation.

On 7/21/2023, I called Resident A's guardian. She expressed satisfaction with his placement stating, "It's the best place so far."

On 7/25/2023, I interviewed Roman Bounds, program manager, who provided the written reprimand for staff Georgia McCaughan. It concluded and she "lost rational detachment" while working with Resident A's during his behavioral episode as he was being verbally and physically aggressive with her, and she used a "bad paraverbal with resident".

On 7/25/2023, I interviewed Resident A. Due to his cognitive impairment and developmental disability he had no recollection of the incident.

On 7/25/2023, I conducted an exit conference with Dan Bogosian, licensee designee.
