II. Purpose of Addendum

Mr. Ganton requested to increase the capacity of the home for the aged (HFA) by adding an additional 9 licensed beds for room labeled M to S.

III. Methodology


On 6/21/2023, Mr. Ganton applied to increase to licensed beds. On 8/17/2023, I completed an on-site inspection. The Health Facilities Engineering Section room sheets were reviewed for the rooms identified to have an increase in beds.

IV. Description of Findings and Conclusions

I reviewed HFES room sheets and determined that rooms labeled M, P, and Q are one licensed bed with 223 sq ft, built in closets, and private bathroom. Rooms labeled N and O are one licensed bed with 277 sq ft, built in closets, and private bathroom. Rooms labeled R and S are two licensed beds with 354 sq ft of floor space, built in closets, private bathroom. Day/dining space is adequate to support this increase of 9 licensed beds.

V. Recommendation

It is recommended that the license capacity increase to reflect 94 licensed beds.
