II. Purpose of Addendum

Joshua Caswell, Interim Executive Director and administrator, Jenny Jacobs, on behalf of Crisis Center Inc-DBA Listening Ear, is requesting Mental Illness be added to the special certification license (SC) as a Program Type. The facility currently is licensed for special certification for the program type developmentally disabled only.

III. Methodology

On June 27, 2023, a new Certification of Specialized Programs Application for Certification was received with Mental Illness added as a program type along with an updated Program Statement to include Mental Illness and additional services provided.

IV. Description of Findings and Conclusions

The Mt. Pleasant Home has been licensed since March 1, 1988 as a Special Certification Adult Foster Care Home for the program type Developmentally Disabled and is requesting to add the program type Mental Illness to their licensure. On June 27, 2023, a new Certification of Specialized Programs Application for Certification was received with Mental Illness added as a program type along with an updated Program Statement to include Mental Illness and additional services provided. Jenny Jacobs is the current administrator serving as the current Licensee Designee and Administrator. Jenny Jacobs is also the Licensee Designee and Administrator over other licensed facilities who have Special Certification for Developmentally Disabled / Mental Illness and she has at least one year of experience working with individuals diagnosed with developmental disability and/or mental illness. She has also completed all other training requirements necessary to meet the requirements of a licensee designee and/or administrator.

V. Recommendation

I recommend the modification request of adding program type Mental Illness to the licensure of the facility be approved.
