(3) A licensee shall record the weight of a resident upon admission and monthly thereafter. Weight records shall be kept on file for 2 years.

Resident A did not have weight records on file for January and February 2023.

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
