	(1) A home shall be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.	
At the time of my inspection, I noted that the countertop behind the kitchen sink is rotting/in poor condition, and it is not impervious to water. The countertop shall be repaired or replaced.

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
