II. Purpose of Addendum

The purpose of this addendum is to determine if Northwest Bedroom 2 is suitable to accommodate two residents.

IV. Description of Findings and Conclusions

On 11/30/23, I conducted an onsite inspection of Sugarbush Living—Beecher Circle House. The licensee designee, Michael Maurice stated that a married couple moved into this facility, and they want to sleep in the same bed, in Northwest Bedroom 2. They wish to use Southwest bedroom 1 as their sitting room area.

I inspected both bedrooms. Northwest Bedroom 2 measures 12×12 , which is 144 square feet. This room can accommodate a full-size bed and two residents. Southwest Bedroom 1 measures 15×13 , which is 195 square feet. The married resident couple wishes to use Southwest Bedroom 1 as their sitting room.

I conclude that the Northwest Bedroom is suitable to accommodate two residents. The licensee designee is aware that he is not to exceed his licensed capacity of 6 residents.

V. Recommendation

I recommend that Northwest Bedroom 2 be approved to accommodate two residents.
