This facility was found to be in non-compliance with the following rules:

R 400.14402	Food service.
	(3) All perishable food shall be stored at temperatures that will protect against spoilage. All potentially hazardous food shall be kept at safe temperatures. This means that all cold foods are to be kept cold, 40 degrees Fahrenheit or below, and that all hot foods are to be kept hot, 140 degrees Fahrenheit or above, except during periods that are necessary for preparation and service. Refrigerators and freezers shall be equipped with approved thermometers.

thermometer.	
R 400.14403	Maintenance of premises.
	(5) Floors, walls, and ceilings shall be finished so as to be easily cleanable and shall be kept clean and in good repair.
During the onsite	e inspection, I observed torn carpet in Bedroom #2.
R 400.14407	Bathrooms.
	(3) Bathrooms shall have doors. Only positive-latching, non- locking against-egress hardware may be used. Hooks and eyes bolts, bars, and other similar devices shall not be used on bathroom doors.
The door to Bath	nroom #1 did not have non-locking against-egress hardware.
R 400.14408	Bedrooms generally.
	(7) Bedrooms shall have at least 1 easily openable window.
During the onsite	e inspection, I observed that the windows in Bedroom #1 and e not easily openable. The window cranks in Bedroom #1 were not
