# ALLEGATION: Resident A is bedbound and has bed rails on her bed that are not authorized by a physician.

#### **INVESTIGATION:**

On 11/22/2023, I received this complaint through the Bureau of Community and Health Systems (BCHS) online complaint system. This complaint alleged Resident A is bedbound and has bed rails on her bed that are not authorized by a physician.

On 11/24/2023, I conducted an interview with social worker Jessie Pressley who stated Resident A participates in the P.A.C.E. program and has an occupational therapist, nurse, social worker, and dietician that visits with her twice a year. Jessie Pressley stated during a recent nurse visit, it was observed that Resident A's bed had bed rails which were not approved by Resident A's physician from P.A.C.E or any other licensed physician. Jessie Pressley stated during the nurse visit, Resident A was observed

sleeping with no other concerns noted. Jessie Pressley further stated the nurse informed licensee designee Susan Dornan that bed rails were not authorized and could not be used on Resident A's bed however the licensee refused to remove the bed rails. Jessie Pressley stated although Resident A is bedbound and cannot move without assistance from staff, P.A.C.E. will not prescribe bed rails for any participant as this method is viewed as a form of restraint which goes against the organization's policy.

On 12/01/2023, I conducted an onsite investigation at the facility with licensee designee Susan Dornan who stated Resident A has very specialized needs and requires a hospital bed with bed rails since she is bedbound and requires total care assistance from staff. Susan Dornan stated Resident A's durable power of attorney agreed to have Resident A use bed rails for added support which is the reason why Susan Dornan installed the bed rails however Susan Dornan has been having difficulty with getting Resident A's physician from P.A.C.E. to prescribe the bed rails. Susan Dornan stated she does not feel comfortable having Resident A reside in her home with her condition without having bed rails as an assistive device for her bed. Susan Dornan further stated she has talked with P.A.C.E. staff members about relocating Resident A to another facility due to her concern.

I also conducted interviews with staff members Dave Dornan and Christopher Dornan who both stated prescribed bed rails have been routinely used for the residents in the facility who are bedbound for increased support however Resident A has utilized bed rails since her admission to the facility without having a written prescription from her physician.

While at the facility, I observed Resident A lying down in her bed equipped with bed rails. No concerns were observed. Resident A was not able to be interviewed due to her cognitive impairment.

APPLICABLE RULE	
R 400.14306	Use of assistive devices.
	(3) Therapeutic supports shall be authorized, in writing, by a licensed physician. The authorization shall state the reason for the therapeutic support and the term of the authorization.

ANALYSIS:	Based on my investigation which included interviews with licensee designee Susan Dornan, staff members Dave Dornan, Christopher Dornan, social worker Jessie Pressley and inspection of Resident A's bedroom, Resident A's bed had bed rails attached that were not authorized by any physician. Jessie Pressley stated that Resident A receives services from the P.A.C.E program and her P.A.C.E. physician will not prescribe bed rails for Resident A's bed due to their company's policy on this assistive device however Resident A continues to have bed rails installed on her bed. Susan Dornan, Christopher Dornan and Dave Dornan also all stated that Resident A has used bed rails for her bed as an assistive device that are not authorized by a licensed physician. In addition, while at the facility I also observed Resident A to have bed rails on her bed and was not provided with any written prescription for the use of these bed rails. Therefore, this assistive device is not authorized for Resident A to use.
CONCLUSION:	VIOLATION ESTABLISHED

On 12/1/2023, I conducted an exit conference with license designee Sue Donan. Informed Sue Donan of my findings and allowed her an opportunity to ask questions or make comments. On 12/1/2023, I received and approved an acceptable corrective action plan.

### IV. RECOMMENDATION

An acceptable corrective action plan was approved; therefore, I recommend the current license status remain unchanged.
